Joel Aggergaard began working for the Washington State Department of Emergency Management in 1970's and served until his untimely death in 1996. He thoroughly enjoyed his career with Emergency Management, and his "heart" was with supporting local Emergency Management Programs. It may be necessary to be a local emergency manager to fully appreciate the enormous contribution Joel made to local programs during the years he worked with emergency management. Joel assisted with countless floods, storms and local emergencies, and was a welcome addition to any activated Emergency Operating Center during a disaster.

Applicants please read this application carefully and follow directions completely. This application must be received complete with all pages attached and sections completed. Incomplete applications will be disqualified.

All applicants must include two letters of recommendation from a teacher, former or present employer, or anyone of your choice other than a relative or a parent.

Applicant must include a current academic history, verifying enrollment and good academic standing.

Please choose **one** of the following essay statements and write a response in 500 words or less. Essay must be typed and submitted on a separate piece of paper. The Essay will be judged on grammar, neatness in appearance and content.

- 1. Describe a person who has influenced you the most to choose a degree in Emergency Management or related field and what you learned from him/her that will help you become a successful person.***
- 2. What contribution do you believe that you will bring to the field of Emergency Management and how?***
- 3. Reflect on why you are choosing to pursue a career in Emergency Management or related field.***
